## Summary of CV

This section describes briefly a summary of your career in science, academic and research; the main scientific and technological achievements and goals in your line of research in the medium -and long- term. It also includes other important aspects or peculiarities.

My academic trajectory has been shaped by war, displacement, immigration, and disability—experiences that profoundly inform my research on state power, legal structures, and identity.

I hold a PhD in Ethics and Political Philosophy (UNED, 2024) and multiple LL.M.s across legal traditions: Legal Theory (Louvain, coursework completed 2003), French Public Law (Rouen), Administrative Law (CEU, 2005), Public Law (UC3M, thesis deposited 2009, defended 2019), Protocol (UNED, 2022), and Military Law (UCAM, interrupted, 2019 by security clearance denial and COVID). This sequence represents a deliberate strategy of epistemic accumulation, engaging systematically with different legal systems, methodologies, and applications to understand law as a multifaceted phenomenon in societies from different epistemic and interdisciplinary perspectives.

My career includes: Associate Professor (UC3M, 2008-2009); Deputy Director, vLex (2006-2011), where I designed database architecture based on my DEA research; CEO, SipCel Telecom (2010-2018), founded during disability recovery; and Legal Expert, IOM (2022), advising the Iraqi Ministry of Migrations on legislative reform and Geneva Convention accession.

Since 2018, I have published in venues including Sage Journals, Oxford University Press, DePaul University of Chicago, and UNAM; presented at Georgetown, Queen's Belfast, and several IPSA events; and hold editorial/reviewer roles with different journals. A monograph is forthcoming with Routledge (2026). My research synthesizes postcolonial critique, constitutional theory, and political philosophy.

At the time, legal databases were transitioning from offline CD-ROMs (as an old market formula) to online platforms. vLex was the first company to make this leap. My role was uniquely dual: 1) Architect of Legal Knowledge Organization: Designed the thesaurus and indexing structure for vLex's pioneering online database. This work translated my academic research on how constitutional doctrine is built and consolidated into a functional, commercial product that organized jurisprudence for legal researchers. 2) Institutional Relations: Within six months, promoted to Deputy Director, liaising between the publisher and bar associations, universities, and the General Council of the Spanish



Judiciary (GCJP). This involved both database design consultation and resource allocation, bridging the private sector with public institutions.

**Applicability in teaching and/or research:** This experience was a direct extension of my academic work. My DEA thesis advocated for free, state-provided legal databases as a public obligation. At vLex, I navigated the tension between private commercial interests and the public good, contributing to a model that would later influence Spain's public legal database (CENDOJ). My research on legal knowledge organization at vLex anticipated current developments in legal artificial intelligence. The indexing and categorization work I led formed the conceptual groundwork for how legal data can be structured for algorithmic analysis. Career interruption note: In July 2009, I suffered a severe accident resulting in long-term disability (officially recognized by Spanish Social Security as absolute incapacity). This interrupted my trajectory at the forefront of legal technology. My contract included a 10-year exclusivity clause upon leaving vLex, which prevented me from continuing work in this sector after my recovery. This led me to channel my innovation capacity into a different technological field (SipCel Telecom) during my period of immobility and recovery, before returning fully to academia to complete my PhD.
