B.1. Breve descripción del Trabajo de Fin de Grado (TFG) y puntuación obtenida In my undergraduate thesis I first studied the algebraic Bethe ansatz, which is an algebraic method that produces quantum mechanical systems with a high degree of symmetry. This symmetry can then be exploited in order to obtain some energy eigenvalues and eigenstates of the quantum mechanical system, partially solving it. In the presence of additional symmetry, the complete spectrum can sometimes be found. The supersymmetric tJ-model arises in this way, and models a finite periodic one-dimensional lattice where a lattice site can either be empty, or be inhabited by a spin-1/2 particle (e.g. an electron) with spin up or down (but not both).

I have then applied the general method in the special case of a lattice of length 3 to explicitly compute the energy eigenvalues and eigenstates.

B.2. Breve descripción del Trabajo de Fin de Máster (TFM) y puntuación obtenida Differential geometry is the study of spaces which are "smooth" in a certain sense. Examples include the three-dimensional space we live in, but also curved spaces such as the surface of a donut. These spaces are not well-behaved under natural set-theoretic operations such as preimages and quotients. In my master's thesis I have studied the method of L-infinity spaces, developed by Kevin Costello, Ryan Grady and Owen Gwilliam, which can be used to encode such singular spaces by equipping a smooth manifold with additional algebraic structure that encodes the singular behavior algebraically in certain cases. I have then shown that the procedure of symplectic reduction, which involves both a preimage and a quotient, can to some extent be included in this framework of L-infinity spaces.
