Las **aportaciones científicas**

1. Ética en Finanzas: Se han publicado varios trabajos significativos. Por un lado, los relacionados con el RAI Radical Affinity Index que permite medir la perspectiva ética de entidades financieras, entre ellas, la comparativa con la banca tradicional, las microfinanzas, la banca islámica o las cajas que se han convertido en bancos. Pone de relieve la importancia de la preocupación por lo social en diferentes ámbitos. Se va desarrollando y contribuyendo al paradigma social, que hoy en día comenzamos a aceptar de forma generalizada. Asimismo, se han realizado trabajos propiamente sobre ética empresarial, entre ellos el de la ética en el pago de proveedores poniendo de manifiesto la importancia que las relaciones tienen entre cliente-proveedor, y exponiendo que la responsabilidad no solo recae en el cliente, sino también el proveedor hace posible este desarrollo de "mala praxis". El Handbook publicado en 2021 en Springer sobre ética en finanzas pone de manifiesto su nivel de relevancia internacional, publicado este junto un co-editor el catedrático Luc Van Liedekerke de reconocido prestigio internacional por sus aportaciones a las finanzas sostenibles y ESG (Vigeo). En esta línea abrir una problemática, como es la de las empresas zombies tras la publicación del problema y los datos descriptivos en revistas Scopus, se consolida su contribución en este tema con dos publicaciones, una en EMJ17 y otra en RMS21(early view). Se desarrolla un índice denominado MOHAI para determinar cuáles son las empresas zombies, y se explican los aspectos de gobernanza que influyen en la creación de las mismas, como lo es el género (menor riesgo y menos zombies) entre otras. También ha desarrollado el MUTUAL CASH HOLDING que consiste en un modelo de gestión conjunta de la tesorería, o un MORAL COMPLIANCE MODEL, un modelo para complementar el Compliance legal, mediante la inclusión del riesgo moral en el sistema de gestión de riesgos de las empresas.

2. Valor Social: Se publica un libro Springer de co-autoría (3 autores) en 2016 (SPI Q1). Además, de un conjunto de artículos WOS yScopus que exponen sus contribuciones en la línea del Valor de Mercado, Ratios de medición sociales, Valor Específico, Generación y Distribución del Valor Social a los Stakeholders, Valor Emocional, uso del VSI para realizar estudios analíticos, tanto en el sector de la Economía Social, como en términos globales. En esta línea se ha generado conocimiento porque se ha desarrollado una contabilidad social que no solo cuantifica sino monetiza el valor que las organizaciones generan para los stakeholders. Estos resultados se han teorizado a partir de colaborar de forma voluntaria con diferentes organizaciones. Esta contabilidad desarrollada permite múltiples opciones, como los análisis de género, GWEI, o los análisis territoriales, incluso otros relacionados con los ODS.

3. Innovación Educativa: todas las investigaciones se intentan trasladar a la educación, pero también se realiza algún trabajo en esta línea, como por ejemplo el de medir monetariamente



el valor del doctorado. También desarrollar la metodología Delphi como instrumento eficiente para progresar en las respuestas de los problemas científicos de la ética en empresa.
